<p>Deadline for adding an FY2 trainee with a potential adverse outcome (3 or 4) to a central panel: Friday 19th June 2020</p> <p>Satisfactory FY2 sign off can take place locally until Friday 24th July 2020</p>	<ul style="list-style-type: none"> <li>• <b>Educational Supervisors</b> to complete End of Year Report.</li> <li>• <b>Foundation Trainees</b> to complete Foundation Form R as part of the ARCP / revalidation process. Form R to be saved on Horus ePortfolio and a copy provided to local Foundation Trust Administrator.</li> <li>• <b>Trust Local ARCP panels</b> are established / convened.</li> <li>• <b>Trust Local ARCP Panels</b> to review the Horus ePortfolio and any additional ARCP evidence submitted.</li> <li>• <b>FTPD</b> assigns an ARCP outcome to the trainee via the FY2 ARCP outcome form on Horus ePortfolio.</li> </ul> <p><b>NB//</b> Dates for period covered on ARCP outcome form is 01/08/2018 to 04/08/2020.</p> <ul style="list-style-type: none"> <li>• <b>Trainee</b> to sign the FY2 ARCP outcome form via Horus ePortfolio within <b>10 working days</b> of the ARCP panel meeting.</li> <li>• <b>Foundation Trust Administrator</b> advise YHFS when trainees have been signed off.</li> <li>• <b>YHFS</b> invites trainees with expected Outcomes 3 or 4 to attend a Central Foundation ARCP.</li> </ul> <p><b>It is recommended that trainees who may receive an adverse outcome (3 or 4) should be seen in the Trust in early June and should be seen at a central panel.</b></p> <p><b>If an outcome 5 is awarded, the local ARCP panel <u>must</u> convene again two weeks later to review whether to outstanding competencies have been achieved, if they have, the trainee can be signed off locally, if not, they can be referred to a central ARCP panel for an adverse outcome or discussed with FSD/Deputy.</b></p> <p>Please discuss trainees with potential adverse outcomes with the FSD / Deputy and advise YHFS by sending the central panel referral form to the generic inbox – <a href="mailto:foundation.yh@hee.nhs.uk">foundation.yh@hee.nhs.uk</a> <b>by Friday 19th June 2020</b>, so they can be allocated to a central panel.</p>

<p><b>By Friday 3rd July 2020</b></p>	<ul style="list-style-type: none"> <li>• <b>FSD / Deputy</b> to review the ARCP panel's recommendation and will sign the FY2 ARCP outcome form on ePortfolio for those trainees awarded with an Outcome 6 (if satisfied)</li> <li>• <b>YHFS</b> issues the "Foundation Achievement of Competency Document" (FACD) to confirm successful completion of the FY2 year.</li> </ul>

<p><b>Deadline to appeal ARCP outcome Friday 17th July 2020</b></p>	<p>Trainees wishing to appeal the outcome of the ARCP Panel must do so in writing, to the Postgraduate Dean within <b>10 working days</b> after they have received the outcome letters from their ARCP.</p> <p><b>Only the process can be subject to an appeal, not the outcome.</b></p>
<p><b>Appeals Panel Wednesday 29th July 2020</b></p>	<ul style="list-style-type: none"> <li>• <b>YHFS Appeals Panel</b> – covers central ARCPs up to Friday 3rd July 2020 ARCP dates.</li> <li>• Appeal panel to convene <b>Wednesday 29th July 2020</b></li> <li>• Outcome to be communicated to the trainee within 5 working days</li> </ul>
